NOTES

1. In-house managers and CEO's are invited to register and can attend all sessions and events, but not the Special General Meeting. Please pass a copy of this registration form to others and encourage them to attend. Those types of attendees pay the Full Delegate Package Rate.
2. Non-member patent and trade marks attorneys who are eligible to apply to become a FICPI member (see Note 5 for eligibility criteria) are invited on a one-time only basis to register at the specially discounted non-member rate (see above) and can attend all sessions and events, but not the Annual General Meeting UNLESS membership is approved before then. Please pass a copy of this registration form to any non-member attorneys you believe may wish to attend on this basis.
3. The Full day or half day conference options cannot be combined. The full day packages include lunch and evening dinner (off-site), while the half day package includes lunch (off-site)
4. Bookings and payment for accommodation is the delegate's responsibility, and the Accommodation Booking should be made ASAP. If you call the hotel - mention you are booking with FICPI Australia. Room rate \$310 on a Thursday evening and \$275 the remaining days and breakfast per person is \$28 and rooms are best booked ASAP.
Delegates and attendees should note the hotels' cancellation policy and transaction fee/s. Please book as soon as possible, noting that bookings are available on a first come first served basis. The Rialto Intercontinental rack room rate may apply after that.
5. The registration fees do not include transport to and from your home city, accommodation, nor any personal room expenses. A tax invoice from FICPI Australia will be issued following registration most likely following the conference, but if required sooner please ask.
6. Eligibility to become an ordinary member of FICPI Australia under Article 5 of the Articles of Association is briefly summarised below; please speak to the Secretary or a Council member if you wish to explore this process further. A prospective member will be a person:
 - in independent practice (e.g. see fourth dot point below) as a Patent Attorney in Australia or as a Trade Marks Attorney in Australia
 - have their primary endeavour as a patent attorney or as a trade marks attorney
 - have at least five years experience as a patent attorney or trade marks attorney since registrations as such in Australia or overseas
 - not practise only on behalf of one client, or an affiliated group of clients, to the exclusion of other clients

Please note that under the amendments made to FICPI Australia Articles of Association, all patent attorneys in private practice for at least five years and trade marks attorneys for a similar period, subject to the additional conditions as specified above, are eligible to become members of FICPI Australia.
